Footnotes

BECKY'S KITTEN forced the pace, bid late turn, dueled into the stretch, was headed but rebid and drew clear under a hand ride. KID CANUCK, in touch, closed inside rivals and bid at the top of the stretch, drove clear but failed to hold. KINGS PARADE raced off the pace, was hustled eight-wide late turn then rallied belatedly. HAILSTONE, in range, was hustled four-wide into the stretch and finished gamely in vain. FOREST JUSTICE stalked the pace, chased on the turn then finished determinedly. BAYLAND raced off the pace, closed along the rail late turn, was all out through the stretch but failed to menace. TRELAWNY stalked the pace, was hustled late turn, came seven-wide into the stretch but evened out in the late stages. EVEN raced midpack, was hustled five-wide late turn then lacked a strong closing response. ALWAYS WILDCATIN', in touch, closed on the turn, came eight-wide to the top of the stretch, chased, but flattened out late. DOCTOR JACK, off slowly, was hustled from well back on the turn but flattened out in the final furlong. CLARKSTONCHARM

led early, set a pressured pace, was headed late turn and tired. JET SET EXEC raced off the pace, was hustled on the turn but never reached contention. BERBERIS raced off the pace from between foes and lacked a rally. GAZUMBA, also off the pace, was hustled on the turn but was never in contention.
